 GVK Emergency Management and Research Institute, a pioneer in Emergency Management Services in India and a not - for - profit professional organization operating in the Public Private Partnership (PPP) mode (here in after referred as GVK EMRI), located at Devar Yamzal, Medchal Road, Secunderabad – 500014 invites bids from various Vehicle-Body-Builders/Repairers (herein after called as Bidder) operating in India for Refurbishment works of Ambulances as per the requirements of GVK EMRI, described in Annexure-1.

The Ambulances for which Refurbishment is required are spread over 14 States and 2 UTs. The tentative number of vehicles in each State which may require refurbishment during the one year period of the rate contract **will be uploaded** in our website **subsequently**.

The vendor shall have all the facilities to carry out the task at the State for which he is quoting.

- 2. List of works:
  - List of the works to be carried out and quantum of repairing to be done are detailed in
     Annexure 1 (155 types of Refurbishment works)
  - Format for quotation of prices is given in **Annexure 2**
  - Format of Declaration Certificate to be submitted by the bidder is annexed in Annexure 3
  - > Information Sheet to be submitted by the bidder is as per Annexure 4
- The tender document with all the details is available in the website of GVK EMRI (<u>www.emri.in</u>). All Bidders who download the document from website have to submit the Demand Draft for Rs.500/- drawn on GVK EMRI, Secunderabad, from any Nationalized Bank payable at Secunderabad, at the time of tender submission.
- 4. Any Bidder who is interested to undertake the Body refurbishment works in accordance with the requirements stated in the attached annexures should carefully read the tender document before filling, signing and returning the same to this office. The Bidder must also furnish all the Information and documents as called for in tender, at the time of tender submission, failing which the tender is liable to be rejected.

- 6. The completed bids must be received at the office of GVK Emergency Management and Research Institute, Secunderabad, India, on or before time and date given above. It will be the sole responsibility of the Bidder to ensure that their bid is received at the address specified above on or before the specified date & time mentioned.
- 7. Bids will be opened in the presence of Bidder/authorized representative(s) who choose to attend the bid opening on the specified date and time at the office of GVK EMRI at the address given above.
- 8. In the event of the last date specified for receiving and opening the bids being declared as a closed holiday for GVK EMRI's office, the last date for submission of bids and opening of bids will be the following working day at the same venue and time.
- 9. Bids will be evaluated separately for each work.
- 10. The bid documents are non transferable.

- 1. DEFINITIONS:
  - a. PO Purchase Order
  - b. EMD Earnest Money Deposit
  - c. DD Demand Draft
  - d. Purchaser GVK EMRI

  - f. Vendor the successful bidder/s, to whom the tender is awarded
- 2. RATES VALIDITY:

The Rates shall be quoted as per the format enclosed at Annexure-2. The rates shall remain firm and fixed for all the work orders placed during the period of Rate Contract.

- TERMS OF DELIVERY: The Bidder shall be responsible to arrange safe delivery of vehicles & material supplied to them by GVK EMRI
- 4. QUALIFICATION CRITERIA FOR ELIGIBILITY OF FIRMS
- a) The Bidder shall have at least 3 years of experience in Body repairing & Refurbishment activity
- b) Bidder should not have been convicted for any criminal or economic offences by any court in India or abroad.
- c) Bidder shall have an average annual turnover of at least Rs. Ten lakhs during the last three financial years.
- 5. SUBMISSION OF BID:

The Bid should be in a sealed cover super-scribed "*Labour charges for Body refurbishment of ambulances* and clearly mention Tender number and date. The Super-scribed sealed cover shall consist of Two sealed covers A and B inside:

- A. Super scribed Sealed Cover A *Pre-qualification cover* : documents to be strictly arranged as per sequence mentioned below
  - a. Index
  - b. Tender fees (as applicable)
  - c. Earnest Money Deposit (EMD) by way of Demand Draft only.
  - d. IT returns and financial statements for last three financial years.
  - e. Copy of PAN Card
  - Relevant registration copies of Factory/trade/labour licenses/ Service tax/VAT/Excise. (Clearly state the applicability with YES or NO and attach copies of certificates)
  - g. Customer feedback/satisfactory certificates from any other organizations and Past performance of the Bidder should be submitted along with relevant - PO copies for at least three financial years
  - h. The bidder shall Sign and Stamp all the pages of tender document
- B. Super scribed Sealed Cover B: Price Bid shall contain rates for all the 155 nature of refurbishment works specified in Annexure-1.





- 6. The Bid should be dropped in the box provided for this purpose at main reception of GVK Emergency Management and Research Institute, Devar Yamzal, Medchal Road, Secunderabad 500 014, India. Bids being sent through courier by outstation Bidder should instruct the respective courier company to drop the sealed Tender document in the designated box kept at the reception.
- 7. The Bid should be properly page numbered, signed on each and every page and should be complete in all aspects.
- 8. Bid documents that do not provide complete information and / or that are submitted after the above specified time shall be rejected.
- 9. Bidder should sign the "Declaration certificate" (Annexure-3) accepting that they have read and understood, all the Terms and Conditions stipulated for in the Tender, and are willing to abide by these tender terms and conditions", before submitting the tender document. Tenders submitted without the Signed declaration certificate will be considered incomplete and will not be considered.
- 10. A maximum of two authorized representatives would be allowed to attend the bid opening. They must submit authorization letters issued by the bidder at the time of opening of bid.
- 11. VALIDITY OF TENDER/ PERIOD OF CONTRACT: The prices quoted are offered in tenders shall remain valid for a period of one year after signing the contract agreement.
- 12. EMD AMOUNT: Bidder should submit an EMD amount of Rs.10000/- (Rupees Ten thousand only) by way of Demand Draft only. Each tender form should be accompanied by EMD amount, as applicable in the form of Demand Draft in favor of GVK EMRI-Secunderabad. For L2 Vendor, EMD would be returned after due acknowledgement (from L1) of the confirmation of PO. For L3 onwards, the EMD will be sent back, in a stipulated time of 30 working days.
- 13. RATES :
  - a. All Quotes shall be in Indian Rupees
  - b. If more than one Bidder has quoted exactly the same rate in their bids, and if it has become the Lowest Bid (L1), the decision of the Purchaser is final to allocate the schedule quantity to either or between the two L1 Vendors.
  - c. All rates should be quoted as per Annexure-2; else all such bids are liable to be rejected at the sole discretion of GVK EMRI.
  - d. If there is only one Bidder for a particular Work, the price will not be disclosed. The committee will go ahead with shopping model.
  - e. The market rate will be compared with the L1 price and if the L1 prices are more than the technically assessed price, GVK EMRI has right to cancel the bid.
  - f. If there is no Bidder for a particular work in annexure, the committee will go ahead with shopping model.





#### 14. TECHNICAL EVALUATION

- a. Technical evaluation of the capacity of the Bidder to execute the jobs and the labour charges quoted in the bid would be done by a Technical Committee constituted by GVK EMRI.
- b. Nothing in ANY OF THE CLAUSES OF THIS CONTRACT shall in anyway release the Vendor from any warranty or other obligations under this contract.
- 15. PLACE OF TENDER OPENING Tender opening will be at GVK EMRI Campus, Devar Yamzal, Medchal Road, Secunderabad-500 014. The venue of all other evaluations will be informed to the Bidders in advance.
- 16. QUANTITY ALLOCATION TO SUCCESSFUL BIDDER Each vehicle will be jointly inspected by both the representative of Successful bidder and the representatives of GVK EMRI & SHTO to assess the quantum of damages to the vehicle and requirement of repairs as per the list of repairs incorporated in the tender document and accordingly the work order would be released to L1 Vendor

However, it is purchaser's decision to assess the capacity of the L1 Vendor to support the requirement. In case, it is assessed that the entire job work cannot be allocated to L1, GVK EMRI reserves the right to allocate the remaining job to L2, L3 and so forth, in the order of Price Bids.

#### 17. SCHEDULE OF REQUIREMENTS:

a. Purchase orders would be released for the requirements after finalization of tender and declaration of L-1 vendor(s). vehicle-wise any time for a period of one year after signing the contract agreement.

#### 18. AUTHORIZATION FOR ATTENDING AND SIGNING OF DOCUMENTS

- a. The person who is signing the tender document should be an authorized signatory of the respective Bidder's organization and shall carry an authorization letter on company's letter head certified by a person not below the Proprietor/Managing Partner/General Manager/CEO/Director/Other Senior level position.
- b. All agents who are participating in the tender on behalf of a manufacturer shall submit valid "Authorization letter" in original duly signed by the Bidder.
- 19. RESPONSIBILITY FOR PERFORMANCE OF CONTRACT The Vendor shall be entirely responsible for the performance of the contract in all respects in accordance with the terms and conditions as specified in the Contract. The Vendor shall not sublet, subcontract, transfer or assign the contract without the written permission of the Purchaser. In case, permission is given by the purchaser, Vendor shall be liable to any loss/damage/quality and timely delivery which the Purchaser may sustain in consequence or arising out of such subletting of the contract.
- 20. VENDOR RESPONSIBILITY

The Vendor should undertake the responsibility for the delivery of Vehicles in satisfactory condition and without any loss or damage at the final destination as per the terms and conditions of the work order. The vendors responsibility continues till the final inspection report is obtained from GVK EMRI. GVK EMRI reserves always to itself, the right of forfeiture of any





amount found due and payable or the deposit, if any, placed by the Vendor for the due fulfillment of the contract as also to recover any amount, if already paid.

21. ALLOCATION

In case if the L1 defaults or if only one Vendor participates in the tender, the decision of tender committee whether to proceed with L2 or to retender is final.

#### 22. DELIVERY

- a. Vehicles allotted to the Vendors will be handed over by GVK EMRI at their works
- b. It is the vendor's responsibility to return the vehicles to the respective GVK EMRI after satisfactory completion of works.
- c. The Vendor should inform about the completion of the allocated works of the vehicle for final inspection
- d. After total completion of refurbishment including attention of any works specified during final inspection, has to be informed to respective GVK EMRI.

#### 23. PENALTY CLAUSE

- a. The Vendor should be able to complete the assigned Body Refurbishment works of the Ambulance allotted to him within 21 days from the date of handing over of the vehicle to him
- b. If the Vendor fails to complete the assigned repairs and inform about completion of the vehicle within 21 days as prescribed above, it will attract penalty of Rs.100/-per every day exceeding the given limit of 21 days.
- 24. ETHICS Any attempt by a Tenderer to obtain confidential information, enter into unlawful agreements with competitors or influence the committee or the Contracting Authority during the process of examining, clarifying, evaluating and comparing tenders shall make the tender submitted by that Bidder liable for rejection/disqualification.

#### 25. TAXES, DUTIES AND LEVIES

- a. Tenderers must clearly mention their Service Tax and VAT Registration Number in their offers and invoices.
- b. In case of any downward or upward revision of Statutory Taxes / Duties / Levies, the same has to be passed to the Purchaser.

#### 26. INDEMNITY

a. The Vendor shall at all times indemnify the Purchaser against all claims which may be made in respect of the items, for infringement of any right protected by Patent, Registration of design or Trade Mark and shall take all risk of accidents or damage which may occur or





failure of the supply from whatever cause arising. The Vendor shall be entirely responsible for the sufficiency of all the means used by them for the fulfillment of the contract.

b. Vendor agrees to indemnify, defend and hold GVK EMRI and its officers, directors, employees, agents, its parent, partially or wholly owned subsidiaries, franchisees, successors and assigns harmless from and against any and all liability, losses, damages, claims, liens, expenses or causes of action including, but not limited to reasonable legal fees and expenses that may be incurred by GVK EMRI, arising directly or indirectly out of, or in connection with, Vendor's violation or breach of any of the terms of this Agreement or any act or omission to act by Vendor in violation of this Agreement. GVK EMRI shall provide Vendor with prompt written notice of any claim for which indemnification is sought and shall have the right to participate in the defense of any such claim.

### 27. QUALITY ASSURANCE:

- a. Vendor represents and warrants that it shall fully comply with all written quality assurance requirements or instructions of GVK EMRI, and as they may be amended from time to time in the sole discretion of GVK EMRI.
- b. Vendor shall maintain the highest standard of quality in the working process. Vendor shall follow and abide by all directions, requests, suggestions or instructions of GVK EMRI regarding the quality standards required by GVK EMRI for the Works.
- c. Vendor agrees to permit GVK EMRI or its agent to inspect the facilities where the works are carried out at all times, without prior notice.
- 28. Warranties and Obligations:
  - a. Vendor shall give a minimum 6 months Comprehensive warranty on the vehicle, from the date of delivery of the vehicle to GVK EMRI for which the Refurbishment is done on the process defects in the process of welding, Tinkering, denting, Painting & stickering etc.
  - b. The Vendor must replace, free of charge, any items which owing to defect in design, and material or workmanship fail or show signs of failure in the stipulated warranty period.
  - c. Replacing the defective items should be done immediately within 15 working days, irrespective of root cause; subsequently, root causing to be done and warranty rules to be implicated.
  - d. GVK EMRI will hold 2% of the labour charges to be paid to the Vendor against the warranty for a period of Six months for each vehicle from the date of delivery of the vehicle from vendor.
  - e. If no such complaint is received from the user units within Six months period as mentioned above, the withheld amount will be released on the certification from Fleet Department.





- 29. Compliance of the Laws of the land
  - a. Vendor shall comply with all state and local laws and regulations regarding the Works shall obtain all necessary licensing for the operation of its business and the Works, and shall further comply with all quality control standards promulgated by GVK EMRI from time to time.
- 30. Documentation requirements:

Vendor has to send the following documents along with the delivery of refurbished vehicle

- a. Invoice in original along with one additional copy, both duly signed and stamped by Vendor.
- b. A copy of Purchase order raised by GVK EMRI
- c. Copy of the job order maintained by vendor
- d. Inspection certificate issued by GVK EMRI
- e. Delivery Note duly signed by authorized representative of GVK EMRI
- 31. Trademarks
  - a. Vendor shall not, without prior written consent of GVK EMRI use the trademarks or service marks or sales marks of GVK EMRI in any manner whatsoever, unless, and then only to the extent, such use is authorized by GVK EMRI in writing and then only in accordance with GVK EMRI's directions or specifications.
- 32. Intellectual Property, Proprietary Knowledge and Confidential Information (Excluding the information in the Public Domain)
  - a. Vendor acknowledges that in connection with this Agreement, GVK EMRI may disclose to Vendor, or Vendor may otherwise obtain or develop knowledge of certain confidential and proprietary information of GVK EMRI, including, but not limited to, trade secrets, intellectual property, future business plans and services, financial, sales,
  - b. Vendor, customer, employee, investor, or other business information related to the business and activities of GVK EMRI.
  - c. All such information is hereby designated by GVK EMRI to be Confidential and Proprietary Information. Vendor acknowledges and agrees that Confidential and Proprietary Information shall not be disclosed by Vendor or any of Vendor's employees, representatives, agents or contractor's without the express written permission of GVK EMRI. Notwithstanding the foregoing, Vendor, during the term of this Agreement, and in order to carry out its obligations under this Agreement may disclose Confidential and Proprietary Information to its EMPLOYEES solely for the purpose of performing its obligations under this Agreement, and only on a "need to know" basis. Vendor agrees that all of its employees receiving any Confidential and Proprietary Information shall enter into a separate written confidentiality agreement with Vendor that ensures the





employee will comply with the confidentiality provisions of this Agreement. A copy of each such confidentiality agreement shall be provided to GVK EMRI.

- d. All Confidential and Proprietary Information shall remain confidential until GVK EMRI designates it as non-confidential or until the information becomes public through no fault of the Vendor.
- e. Vendor shall not be liable for the disclosure of Confidential and Proprietary Information if made in response to a valid order of a court or authorized agency of government; provided that fifteen (15) days notice first be given to the GVK EMRI so a protective order, if appropriate, may be sought by GVK EMRI.
- f. Vendor agrees that in the event Vendor or any of its employees, contractors, representatives, or agents breach the provisions of this Article, such breach or threatened breach would cause irreparable harm to GVK EMRI, and in such instance, GVK EMRI shall be entitled to injunctive and other equitable relief to prevent such breach or to remedy any actual breach.

## 33. Termination

- a. GVK EMRI's Right to Terminate for Cause.
  - i. GVK EMRI shall have the right to immediately terminate this Agreement by giving a written notice to Vendor in the event that Vendor does any of the following:
    - Fails to attend and complete the works as per target delivery date.
    - Files a petition in bankruptcy or is adjudicated bankrupt or insolvent, or makes an assignment for the benefit of creditors or an arrangement pursuant to any bankruptcy law, or Vendor discontinues its business or a receiver is appointed for Vendor or for Vendor's business and such receiver is not discharged within thirty (30) days
    - Breaches any provision of this Agreement, and fails to cure such breach within seven (7) days after it receives a written notice of breach from GVK EMRI.
  - ii. GVK EMRI'S Right to Terminate without Cause.
    - GVK EMRI shall have the right to terminate this Agreement upon sixty (60) days written notice to Vendor.
- b. Vendor's Liability and Right to Terminate

Vendor shall have the right to terminate this Agreement at any time after the first 6 months of the Term on Sixty (60) days prior written notice to GVK EMRI, subject to completion of the pending works for which work orders are issued and vendor has acknowledged such orders. GVK EMRI reserves the right to recover any differential cost (arising from the work allocation to any other vendor) for unexecuted or partially executed orders





#### 34. Infringements

- a. Vendor agrees to fully cooperate with GVK EMRI in the prosecution of any such suit against a third party and shall execute all papers, testify on all matters, and otherwise cooperate in every way necessary and desirable for the prosecution of any such lawsuit.
- b. The GVK EMRI shall reimburse the VENDOR for any reasonable expenses incurred as a result of such cooperation.
- 35. Governing Law; Dispute Resolution

This Agreement shall be governed by, and construed in accordance with, the laws of the India; without regard to conflict of law principles, and under jurisdiction of respective State high courts and language shall be English.

- 36. Notice
  - a. Any notice required to be given pursuant to this Agreement shall be in writing and delivered personally or by a nationally recognized overnight courier service, or mailed by certified or registered mail, return receipt requested, to the other party at its address as set forth at the top of this Agreement.
  - b. All such notices shall be effective upon delivery or upon refusal to accept delivery.
  - c. Either party may change the address to which notice is to be sent by written notice to the other in accordance with the provisions of this paragraph.
- 37. Miscellaneous
  - a. The parties to this Agreement are independent contractors. Nothing contained herein shall constitute this arrangement to be employment, a joint venture, a partnership, a franchise or an agency between the parties. Neither party has the authority to bind the other or to incur any obligation on its behalf.
  - b. No waiver by either party of any default shall be deemed as a waiver of prior or subsequent default of the same or other provisions of this Agreement.
  - c. If any term, clause or provision hereof is held invalid or unenforceable by a court of competent jurisdiction, such invalidity or unenforceability shall not affect the validity or operation of any other term, clause or provision, and such invalid or unenforceable term, clause or provision shall be deemed to be severed from the Agreement.
  - d. This Agreement constitutes the entire understanding of the parties, and revokes and supersedes all prior agreements between the parties, and is intended as a final expression of their agreement. It shall not be modified or amended except in writing signed by the parties hereto and specifically referring to this Agreement.
  - e. Vendor or employees of Vendor cannot claim or construed as employees of GVK EMRI.
- 38. Force Majeure
  - a. If either the Vendor or GVK EMRI be prevented from discharging its or their obligation under this Agreement by reason of arrests or restraints by Government or people, war, blockade, revolution, insurrection, mobilization, strikes, civil commotions, Acts of God, Plague or other epidemics, obstruction of the works by fire or flood or other natural





calamity, loading or discharge, the time for delivery shall be extended by the time or times not exceeding two months, during which attention of works is prevented by any such causes as hereinabove mentioned. The party invoking protection under this clause shall within 2 (two) days of the occurrence of force majeure causes put the other party on notice supported by self certificate and documentary evidence of such incident and shall likewise intimate the cessation of such causes. The delivery shall be resumed by the Party/Parties within 15 (fifteen) days from the cessation of the force majeure causes.

- b. If there is any interruptions in the completion of works due to force majeure circumstances hereinabove, it is hereby mutually agreed between GVK EMRI and the Vendor that the period of off take of the Works by GVK EMRI /period of delivery of the Works by the Vendor may be, at the sole discretion of GVK EMRI, extended by a period not exceeding two months, equal to the actual duration of the causes interrupting the off take by the GVK EMRI and/or delivery of the vehicle by the Vendor PLUS a period of one week to enable the affected party to make suitable arrangements for normalization of delivery of refurbished vehicles.
- 39. Non-Liability of GVKEMRI
  - a. It is expressly understood and agreed by, between the VENDOR and the GVK EMRI that GVK EMRI is entering into this Agreement solely as a PPP (Public Private Partnership) partner of respective State Government. In particular, it is expressly understood and agreed that, any delay in the release of vendor payments, for the supplies made under this tender, solely depend on timely receipt of funds for the same from the state government. The VENDOR expressly agrees, acknowledges and understands that the GVK EMRI is not DIRECTLY responsible for any delays in the release of funds from respective state governments for what so ever reason it may be and shall not hold GVKEMRI responsible for delayed payments and GVKEMRI shall not be liable for any acts, omissions, commissions, breaches or other wrongs arising out of the contract. Accordingly, the VENDOR hereby, expressly waives releases and foregoes any and all actions or claims, including cross claims, impleader claims or counter claims against the GVKEMRI arising out of this Agreement and not to sue GVKEMRI for any reason, as to any manner, claim, cause of action or thing whatsoever arising of or under this Agreement.
- 40. Dispute Redressal Committee:
  - a. All disputes can be addressed by amicable settlement by committee constituted by COO –GVK EMRI, Andhra Pradesh.





- 41. Declaration by the Tenderer
  - a. The Tenderer shall be required to declare whether the proprietor or any partner of the firm or Director of their company as the case may be, has any relation with any employee working with the Purchaser and if so, give the name of the employee and the relationship
- 42. Waiver
  - a. Failure to operate or to enforce any condition under this Contract shall not operate as a waiver of the condition itself or any subsequent breach thereof.

#### 43. Payment Terms

- a. The payment will be cleared within 15 days of delivery, inspection, acceptance and submission of invoice.
- b. The Vendor should submit the bills/invoices with delivery challan and order copy with satisfactory inspection report of the designated Technical person from fleet department after Delivery duly signed and accepted, should be submitted to SCM Department of <u>GVK EMRI, Andhra Pradesh</u> in original.
- 44. FALL CLAUSE
  - a. The prices quoted for the labour charges under this tender by the Bidder shall in no event exceed the lowest price at which the Bidder sells or offers to sell similar services in similar volume of identical description to any person(s)/organization(s) including the Purchaser or any other GVK EMRI office located at any other place in India. If at any time during the said period, the Bidder reduces the charges , offers to any person(s)/organization(s) including the Purchaser or any Statutory Undertaking of the Central or a State Government, as the case may be, at a rates lower than the rates chargeable under this contract, he shall forthwith notify such reduction or rates to the Purchaser and the rates chargeable under the contract for the works listed after the date of coming into force of such reduction or rate or offer of reduction stand correspondingly reduced.
- 45. I/We convey our unconditional acceptance to all the terms and conditions specified herein.
