General brief about 1-0-8 Operations of GVK EMRI:

GVK Emergency Management and Research Institute (GVK EMRI) was established as a not-for-profit Society, registered under Societies Registration Act, 2001, in February 2005 and it provides Integrated Emergency Medical Response services free of cost through a toll free number '108' to every citizen of our country under Public Private Partnership (PPP) frame work. Vision of GVK EMRI is to support and build capabilities to save one million lives per annum nationally and establish GVK EMRI as a premier Research and Training Institute.

GVK EMRI, under the Public-Private-Partnership, has made substantial progress over the last six years in providing Emergency Response Services across the country and presently operate over 10,800 state-of-the-art ambulances in 15 States and 2 Union Territories viz Andhra Pradesh, Telangana, Tamil Nadu, Karnataka, Goa, Gujarat, Dadra Nagar Haveli Daman & Diu, Chhattisgarh, Assam, Meghalaya, Uttarkhand, Himachal Pradesh, Uttar Pradesh, Arunachal Prasad, West Bengal and Rajasthan to provide pre-hospital care covering a population of 750 million. 1. Old scrap Tyres will be sold as it is position.
2. Transportation from location, loading and other charges will be borne by vendor only
3. Payment to be made to GVK EMRI in the form of DD only.
4. Handing over of old scrap tyres will be only after receipt of amount.
5. Successful bidder has to purchase scrap tyres with the finalised price for a period of one year.
6. Approx quantity of old Scrap tyres now available at GVK EMRI, devaryamzal, Medchel Road as on date is 1000 numbers.
7. Apart from the above quantity, every month 150 to 200 scrap tyres to be procured by successful bidder with the price finalised.
8. Quantity of old tyres may increase or decrease.
9. GVK EMRI shall at its sole discretion may negotiate with H1 vendor.
10. Quotations to be submitted as per the format attached as annexure-1
11. GVK EMRI has right to cancel this tender any time without assigning any reason
12. Along with sealed quotation vendor has to submit signed copy of this documents as accepted the terms and conditions.
13. Caution deposit of Rs. 10,000/- in the form DD to be submitted by bidder along with bid documents, this caution deposit does not carry any interest. Successful bidder has to keep this caution deposit till completion of this contract i.e for a period of one year.
