#### General brief about 1-0-8 Operations of GVK EMRI:

GVK Emergency Management and Research Institute (GVK EMRI) was established as a not-for-profit Society, registered under Societies Registration Act, 2001, in February 2005 and it provides Integrated Emergency Medical Response services free of cost through a toll free number '108' to every citizen of our country under Public Private Partnership (PPP) frame work. Vision of GVK EMRI is to support and build capabilities to save one million lives per annum nationally and establish GVK EMRI as a premier Research and Training Institute.

GVK EMRI, under the Public-Private-Partnership, has made substantial progress over the last six years in providing Emergency Response Services across the country and presently operate over 10,600 state-of-the-art ambulances in 14 States and 2 Union Territories viz Andhra Pradesh, Telangana, Tamil Nadu, Karnataka, Goa, Gujarat, Dadra Nagar Haveli Daman & Diu, Chhattisgarh, Assam, Meghalaya, Uttarkhand, Himachal Pradesh, Uttar Pradesh and Rajasthan to provide pre-hospital care covering a population of 750 million. Everyday GVK EMRI is serving on an average 25,000 emergencies (43 million emergencies attended since inception) and saving over 713 lives every day and cumulatively have saved more than 16.8 lakh lives since the launch of the services and provide direct employment to over 44,600 associates while continuing to be a not-for-profit organization.

#### **General Terms and conditions:**

- 8 mbps internet connectivity leased line (ILL 1:1 uncompressed and un shared). The bidder should be the Tier 1 national ISP and should have a valid Category "A" ISP license from Govt of India.
- 2. Internet Service Provider (ISP) must have DOT license to set up and operate international gate ways.
- 3. ISP should have their own /direct access to international gate way in India, for providing internet bandwidth, which should be connected on to international fiber systems only.
- 4. Should have at least one international point of presence for peering with 1 Tier carriers and local peering with in India with at least one other ISP.
- 5. ISP should provide 8 mbps bandwidth and 16 public IP address.
- 6. The ISP provider should have net work Operation Centre (NOC) in Hyderabad for trouble shooting around the clock.
- 7. Vendor should provide 99.5% uptime.
- 8. Payment Terms: payment will be made after completion of every quarter and against submission of bills.
- 9. Present Agreement with Govt. of TS and Govt. of AP is going to expiry soon and likely to renew with GVK ERMI.
- 10. Total 8 mbps band width will be used for GVK EMRI AP & GVKE MRI TS in the ratio of 58: 42 accordingly purchase orders will be raised from GVKE MRI AP & GVKEMRI TS separately in the ratio of 58:42, Consequently vendor should raise the bills and payment will be released from GVK EMRI.
- 11. Successful service provider has to provide services for a period of one year and can be extended with mutual understanding for further period.
- 12. Successful service provider has to provide required infrastructure and other required instrument with free of cost.
