2. PRICE VALIDITY: Prices shall be quoted as per the format enclosed at Annexure-1. Price will remain firm and fixed for all orders placed during the contract period i.e. 1 year.
3. TERMS OF DELIVERY: Vendor will deliver the goods as per point no. 10 schedule.
4. Participant vendor should not have been convicted for any criminal or economic offences by any court in India or abroad.
5. SUBMISSION OF -The quotations should be in a sealed cover super-scribed "sealed quotations for Apron clearly mention sealed quote number and date.

The Super-scribed sealed cover shall consist of two sealed covers inside:
