Vision of EMRI GHS is to support and build capabilities to save one million lives per annum nationally and establish EMRI GHS as a premier Research and Training Institute. EMRI GHS, under the Public-Private-Partnership, has made substantial progress over the last Eighteen years in providing Emergency Response Services across the country and presently operate over 15,235 state-of-the-art ambulances in 15 States and 1 Union Territories viz Telangana, Tamil Nadu, Karnataka, Goa, Gujarat, Dadra Nagar Haveli, Daman & Diu, Assam, Uttar Pradesh, Rajasthan, West Bengal, Kerala, Delhi, Andhra Pradesh, Arunachal Pradesh, Jharkhand and Uttarakhand to provide pre-hospital care covering a population of 980 million. SUBMISSION OF SEALED QUOTATION-

- The sealed quotation should be in a sealed cover super-scribed "SEALED QUOTATION FOR SALE OF SCRAP"
- 2. The Super-scribed sealed cover shall consist of two sealed covers inside:
 - A. Super scribed Sealed Cover A Prequalification cover: documents to be strictly arranged as per sequence mentioned below
 - a. Document fee (Nonrefundable) -2000/- in the form of DD for all vendors
 - b. Security deposit 25,000/- for scrap (other than scrap tyres), for scrap Tyres Rs. 10,000/- in the form of DD.
 - c. Vendor Information form
 - d. Signed and stamped sealed quotation documents on all pages.
 - B. Super scribed Sealed Cover B: Price Bid as per format in *Annexure-1*. Sealed quotations are liable for rejection at sole discretion of EMRI GHS if prices are not quoted as per format provided.

Cover B, price bid will be opened for Vendors, who have submitted all requirements mentioned cover A, other vendors will be disqualified and will not be considered their price bids.

General Terms and conditions:

- 1. All scrap will be sold as it is position (other than scrap Tyres).
- 2. Transportation charges from location, loading, etc., will be borne by successful vendor only.
- 3. It is suggested that, scrap vendor who is going to submit sealed quotation to inspect scrap available.
- 4. Payment to be made to EMRI Green Health Services in the form of DD only.
- 5. Handing over of scrap will be only after receipt of total amount.
- 6. EMRI GHS shall at its sole discretion may negotiate with H1 vendor. H1 vendor means, Highest price quoted among all vendors
- 7. H2 vendor means, second highest price quoted among all the vendors.
- 8. Quotations to be submitted as per the format attached as annexure-1.
- 9. Vendors has to submit vendor information as per the annexure -2.
- 10. EMRI GHS has right to cancel this tender any time without assigning any reason.
- 11. Apart from sealed quotation, vendor information form, vendor has to submit signed copy of this documents as accepted the terms and conditions.
- 12. Sealed quotation of Vendors, who have not submitted required documents will be rejected with sole discretion of EMRI GHS.
- 13. Security deposit to be submitted in the form of DD by vendor along with sealed quotation documents, this security deposit does not carry any interest.



- 14. Security deposit will be returned to successful vendor after lifting of entire scrap.
- 15. DD should be drawn on "EMRI GREEN HEALTH SERVICES" payable at Hyderabad.
- 16. DD taken from cooperative banks will not be accepted.
- 17. Other than H1 and H2 vendor's security deposit DD will be returned to respective vendors on the same day of sealed quotations opened.
- 18. If H1 vendor lifts the material, H2 vendor's Security deposit DD will be returned with in maximum of 30 days.
- 19. If H1 Vendor fails to pay and lift the material within seven days, his security deposit will be forfeited.
- 20. If H1 vendor fails to lift the material, H2 vendor has to lift the material with price quoted by him or negotiated price, whichever is higher.
- 21. If H2 vendor fails to pay and lift the scrap with negotiated price or H2 price (whichever is higher) within ten days from the date of confirmation, his security deposit will be forfeited.
- 22. H1 vendor of tyres rate will be valid for minimum of one year, H1 vendor of tyres has to accept scrap tyres with H1 Price for a period of minimum one year or mutually accepted period whichever is higher.
- 23. Security of deposit of H1 vendor of tyres will be returned after minimum of one year or mutually agreed period whichever is higher.
- 24. H1 rate will be valued separately for scrap tyres and for other Scrap
- 25. After opening of sealed quotations necessary communication will be sent to their email IDs, hence requested all vendors to provide email ID in vendor information form.
