**B. PROCEDURE FOR SUBMITTING TENDER DOCUMENT**

- A. The tenderer should invariably submit his tender in three sealed covers separately namely [1] Tender Fee, [2] E.M.D. covers [3] Technical Supporting Documents.

**All these covers are again put in single envelope super scribed with the tender no. EMRI GHS/GJ/ET/REFU-RT/2025-26 for Refurbishment of Operational Karuna Animal Ambulance.**

Online tender(s) without physical submission of tender fee, EMD and supporting documents duly signed will not be considered and will be summarily rejected.

- B. **Only Online commercial bids will be considered and price bids in other (Physical) form will not be accepted. Bidders are advised to upload required documents to establish their eligibility in online tender form on website. Copies of uploaded documents need to be physically submitted along with Tender fee and EMD at EMRI Green Health Services Gujarat office.**
- C. Tender received in any other form will not be accepted.

**D. Tender fee and EMD Cover**

- 4.1 Payment towards Tender Fee must be made by Demand Draft (DD) payable at Ahmedabad at any Nationalized / schedule bank in favour of EMRI Green Health Services.

**4.2 EMD has to be submitted**

in form of Demand Draft in favor of EMRI Green Health Services drawn on any bank in Ahmedabad OR irrevocable Bank Guarantee issued by Nationalized Bank including the Public Sector Bank / Private Sector Bank / Regional Rural Bank of Gujarat / Co-operative Bank of Gujarat mentioned in GR No. FD/MSM/e-file/4/2023/4020/D.M.O., Dt.11/03/2024 of Finance Department, Govt. of Gujarat as amended from time to time will be followed. The DD/BG should be issued by bank after the date of advertisement of tender enquiry.

- 4.3 Bank Guarantee will be accepted in case, where amount of EMD exceeds Rs.5000/- B.G. should be valid up to 6 months from the date of its issuance. E.M.D. in any other form will not be accepted.
- 4.4 Payment should be made in favor of "EMRI Green Health Services" Ahmedabad, Gujarat, India.
- 4.5 Payment made toward Tender Fee will not be refunded.
- 4.6 Non-payment of the Tender Fee will make the tenderer liable for disqualifications.

**4.7 EMD would be refundable under following conditions:**

- a) Tender is cancelled or closed at any stage of procurement.
  - b) Rejection of bid at primary or technical scrutiny level.
  - c) After issuance of Rate Contract/Purchase Order.
- 4.8 Non- payment of the EMD will make the tenderer liable for disqualifications.

4.9 Bidder Seeking Exemption must enclose following necessary documents.

- a) Micro & small-scale enterprises which participate directly in tendering process for the product which they are manufacturing / service which they are providing and having Udyam registration for items / service under procurement and having registration with CSPO or National Small Industries Corporation.
- b) Startups which participate directly in tendering process for the product which they are manufacturing / service which they are providing and recognized by DPIIT under the Start-up India Program and has obtained Udyam registration & CSPO/NSIC registration as MSE.

4.10 Wrong / Fraudulent data submission may lead to disqualification /debarment. Please ensure that you furnish correct data.

### **C. TENDER EVALUATION:**

Tender will be evaluated in three stages:

#### **a. Preliminary evaluation:**

- 1. Tenders will be scrutinized for their adequacies in terms of Tender Fee, EMD and required Documents with Tender as per Annexure I.
- 2. All vendors are requested to strictly submit the documents in sequence as per preliminary evaluation criteria.

#### **b. Technical evaluation:**

- 1. Technical evaluation of the item tendered will be done by a Technical Committee constituted by the COO EMRI GHS GUJARAT.
- 2. Tender submitted with basic specifications mentioned in this tender form will only be considered.

All vendors who meet the preliminary criterion and submit technical bids conforming to the technical evaluation criterion will be shortlisted for commercial evaluation.

Tender committee may scrutiny the details provided by the vendor and will decide the eligibility of the vendor to next stage.

### **Eligibility Criteria:**

Online Bid for Refurbishment of Operational Karuna Animal Ambulances as mentioned in the tender details section is invited online, following being the eligibility criteria:

#### **Mandatory:**

- i. Only India based reputed Vehicle Manufacturers / body builders for Ambulance Supply/Fabrication are eligible to participate in the bid.
- ii. Only vendors who have prior experience in fabricating Ambulances and automotive interiors in FRP are eligible to participate in the bid.



- iii. Only vendors who have turnover of at least Rs. **95** Lakhs per year, during last three financial years are eligible to participate in the tender.

**Desirable:**

- i. Vehicle manufacturers capable of supplying fully built ambulance as per specifications will be eligible to participate.
- ii. The Technical Committee reserves the right to approve the design/layout and to carry out changes in fabrication during the fabrication of whole supply of bid quantity.

Tenderers who have been blacklisted/ debarred by tender inviting authority or by any other State Government or Central Government department/Organization shall not be allowed to participate in the tender process during the period of blacklisting / debarment.

Only 'Class-I Gujarat MSE', 'Class-I Local Supplier', 'Class-II Gujarat MSE' and 'Class-II Local Supplier', as defined under Gujarat State procurement policy 2024 , shall be eligible to participate in bid/tender.

**The legible and certified copies of the following Technical supporting documents must be submitted as mentioned in Annexure.**

- I. Manufacturing license: Industrial license / I.S.I. Certificate / Factory Inspectors license / Product permission {if applicable}/ Registration certificate with C.S.P.O./ S.S.I./ K.V.I.C./ N.S.I.C./ D.G.S.&D / MSME Part-II acknowledgment /SIS registration and Central Excise Registration /Udyog Aadhar acknowledgment of the Bidder or Principal manufacturer {whichever is applicable}.
- II. Copy of the Partnership deed / Memorandum of Articles / Registration of Firm {whichever is applicable}.
- III. GST registration copy.
- IV. Permanent Account number (PAN) copy.
- V. Empanelment form giving all financial / market / statutory details about firm / company (Annexure XI).
- VI. CA Certified Turn Over details must be enclosed for the past 3 financial years as a compliance to **average turnover Rs.95 Lakh / annum.**
- VII. Only one bid will be accepted from a Group of companies and entities.
- VIII. Documents mentioned in Eligibility criteria.
- IX. Literature or Catalogue of the quoted product/item (if applicable)
- X. Affidavit in ORIGINAL on Non-Judicial Stamp Paper of Rs. 100/-duly attested by First Class Magistrate / Notary public. (Annexure-XIII)
- XI. Performa For Performance Statement (Annexure – XVI)
- XII. All photocopies are required in self-attestation mode except Annexure-XIII which needs to be attested by First Class Magistrate / Notary public.
- XIII. Entire Tender Document with annexure duly signed & stamped.

EMRI GHS shall consider the information furnished by vendor on technical requirements as sufficient and qualify the vendor for price bid opening. If, at any stage of pre-supply and post supply period, if it is found that any information furnished by the vendor is either false or hidden or fabricated, such vendor may be blacklisted by EMRI GHS and prohibited from participating in any of future tenders for a period of 5 years. EMRI GHS may at its sole discretion will use

services of a third party to verify the authenticity of the data furnished by vendors.

All vendors who meet the preliminary criterion and submit technical bids conforming to the technical evaluation criterion will be shortlisted for commercial evaluation.

**c. Commercial evaluation**

Commercial Bids of the vendors, who qualify in the Technical Bid Evaluation, will be opened online. L-2 and other qualified vendors will be contacted only if L-1 vendors fail in delivery schedules/any other tender terms and conditions.

L1 will be decided on total landed cost. Please refer Commercial Bid format mentioned in Annexure – XV.

**Commercial Bid:**

- 1.1 The commercial bid submission should be done on the website only <https://www.nprocure.com>
- 1.2 The bids should be submitted on or before the time stipulated in tender notice at the website <https://www.nprocure.com>
- 1.3 Any type of price can not be disclosed in physical documents otherwise bid will be rejected.

**Note:**

No tender will be accepted after prescribed closing time for submission of the same. The delay will not be condoned for any reason whatsoever including postal/transit delay. However, if the last date of submission of tenders is declared as a holiday by the Government, the last date of submission of tenders will be extended to the next working day.

**'Margin of purchase preference'** means the margin for purchase preference shall be maximum to the extent of 20% over the price/rate quoted by L1 bidder. This means price/rate offered by any bidder above 20% of L1 bidder shall not be eligible for purchase preference as per Gujarat State Procurement Policy 2024.

**D. GENERAL TERMS & CONDITIONS OF TENDER**

- a) Body repair in Refurbishment - Annexure - III
  - b) Interiors Refurbishment work – Annexure - IV
  - c) Technical and Material specifications - Annexure - V
  - d) Exterior Graphics Refurbishment Items - Annexure - VI
1. Before submission of any tender, the tenderer must verify that they have submitted all relevant certificates / permissions / registration documents in proper format along with tender. No intimation of missing documents and no documents will be accepted thereafter and the tenders will be processed on the basis of available documents / certificates. If the requisite documents are not submitted or even if submitted are not in proper format, the tender is liable to be rejected.

EMRI GHS GUJARAT may seek any clarification / explanation / documentary evidence related to offer at any stage from tenderers if required. However, any clarification / explanation or documentary evidence leads to implication on quoted price, it shall be considered only for technical evaluation but not for price evaluation.

2. A firm/Group are allowed to submit only one proposal. In case they submit or participate in more than one proposal by any group all the proposal submitted shall be disqualified.
3. **The E.M.D. / Security Deposit shall liable to be forfeited in the following circumstances when the,**
  - (a) Tender is rejected due to failure to supply the requisite documents in proper format or giving any misleading statement or submission of false affidavit or fabricate documents.
  - (b) Party fails to sign the agreement for entering into contract in case the offer is accepted, due to any reason whatsoever.
  - (c) Party fails to supply the goods / items as per the orders / R.C. placed by EMRI GHS GUJARAT within the delivery period so stipulated time line.
  - (d) Party fails to replace/correct the supplied material declared to be wrong / different from specification and R.C. holder / successful bidder has to refund the cost of such goods.
4. **Back out from tender at any interim level during tender processing:** -Once the tenders are submitted it will be the responsibility of the tenderer not to escape halfway directly or indirectly by way of raising any problems.
5. In no case the certificate should be dated earlier than one year {unless otherwise specified} and should be in force and valid on the last date of the submission of the tender / signing of the agreement {as the case may be}. In case, the certificates / licenses / permission are outdated or the validity period is over, the proof of applying for renewal should also be attached. Such certificates will be considered if the renewal has been applied for within the time limit prescribed for the renewal of that permission / license /certificate under the relevant rules and further if such application for renewal is not specifically rejected by the competent authorities. In case any certificate is still awaited from the competent authority, the proof of making the application should also be attached which will be considered if the application is not specifically rejected by the competent authorities.
6. The tenderer must satisfy that they are in possession of the requisite permissions / licenses / permits required for the supply of the items for which the offer is made. Failure to enter into contract if selected or to execute the purchase orders after entering into contract for want of permission /license or due to non-supply of certificates / documents will be viewed seriously and will invite forfeiture of E.M.D. / risk purchase / disqualification for 2 years without any further reference.
7. The tenders will be opened online on the date, time specified in tender notice. In the first instance, only "Technical bid" will be opened online on the date of opening the tender and taken into consideration for finalization. Subsequently, the "commercial bid" will be opened online only for those tenderers whose quotations satisfy the technical requirement of the indenter and are otherwise acceptable.
8. **The tender is liable for rejection due to any of the reasons mentioned below:**
  - i. Non-Submission of tender within stipulated time online.
  - ii. Submission of tender without Tender Fee.
  - iii. Tender is unsigned OR not initialed on each page or with unauthenticated corrections.
  - iv. Submission of tender documents in unsealed envelope.
  - v. Tender not submitted in separate envelopes as per conditions and the envelopes are not super scribed with details of the tender enquiry and part enclosed.

- vi. Non-payment of Earnest Money Deposit {if not exempted.}
- vii. Non-submission of required documents as shown at Eligibility criteria section.
- viii. Conditional and / or vague offers.
- ix. Unsatisfactory past performance of the tenderer.
- x. Rates have been shown elsewhere than Commercial bid.
- xi. Items with major changes / deviations in the specifications / standard / grade / packing / quality are offered in Technical bid.
- xii. Submission of misleading / contradictory / false statement or information and fabricated / invalid documents.
- xiii. Tenders not filled up properly.
- xiv. Non-submission of Turnover Certificate.
- xv. Non-submission of documents mentioned in List of Annexure wherever applicable.
- xvi. Non-submission of document mentioned above in Technical supporting documents.

Tender Evaluation will be governed by Gujarat State Procurement Policy 2024, Dt.14.03.2024. All bidders are requested to refer policy to comply with the provisions of the same.

## **E. TERMS OF SUPPLY**

### **1. Price:**

- i) The final price quoted in the online bid should be inclusive of **details and specifications** mentioned in tender document. The price offered in the online tender should be as per the FINANCIAL BID format consisting of all costs, duties and taxes applicable,
- ii) All costs and tax components should be shown separately in the Invoice. EMRI GHS may claim back the Input Tax Credit wherever permissible.
- iii) Bidders while bidding should consider the scrap/salvage value of the unwanted additional accessories/ fitments of OEM's vehicle to be removed if any.
- iv) EMRI GHS may at its sole discretion may negotiate with the L-1 vendor to further reduce the prices; in case it is felt that L-1 prices are more than prevalent market prices or any other reason in the interest of respective state Government.
- v) Tenderer should quote their prices in the scheduled format supplied in this online tender form. Price Bids received in any other form will not be entertained.
- vi) For online comparison purpose, bidders must furnish the rates for all the items, Items missed or left blank will be treated as zero cost (No items should be left as Zero Cost until there is a quantity given in repair/replace column or unless items to be carried out free of cost by vendor.
- vii) The item quantities mentioned are indicative and actual execution is fully dependent on the vehicle condition, hence it may vary.

### **Transportation:**

- i. Karuna Ambulance for refurbishment will be provided to and collected back from the vendors located within Gujarat by EMRI GHS and transportation cost will be borne by EMRI GHS.

- ii. For the Vendors located outside Gujarat, they need to establish the entire setup of carrying out the fabrication / refurbishment work within Gujarat to minimize the downtime and facilitate the smooth logistics and support to our 24x7 operations.
- iii. In case vendor fails to provide onsite service, for repeated/same complaint occurring within the warranty period/ vendor had to bear all the transportation cost @ Rs. 15 per KM (Distance of Location to workshop and back to location) payable to EMRI GHS.

## **2. Warranty:**

- A) Equipments like Siren, Amplifier of Grand/Garud make or any other reputed brand approved by EMRI GHS Technical committee should have minimum 1 year warranty from the date of delivery of vehicle.
- B) Tube light, Fans, Inverter, switch board and baby warmer light should have minimum 1 year warranty from the date of delivery of vehicle.
- C) The inverter supplied with fabrication (Preferable M/s Luminous 1050VA sine wave as a process of standardization in all our ambulances) should carry minimum one year's warranty or as per OEM.
- D) The vehicles refurbished will be covered under unconditional on-site warranty for a period of 1 year for the delivery executed under this tender.
- E) The complaint within warranty should be resolved within 5 days of lodging/reporting the complaint. Delay in response will attract a penalty / liquidated damage of Rs. 250 per day for operationally critical complaint which will be decided by EMRI GHS and will be abiding to all the vendors.

If no reply comes within the above stated time period, EMRI GHS will repair/replace the complaint at local level without any intimation / estimate to be given to vendor and the same amount would be recovered from the Bill or Deposit amount.

## **3. Work Content Assessment and Inspection:**

The nature of work being unique in case of every vehicle as per the wear and tear thereof, the inspection for works to be carried out on case to case basis will be done by authorized representative of EMRI GHS prior to raising the work order for a specific vehicle.

Addition alteration if any in the work content of the work order can be done on receipt of approval from the authorized person of EMRI GHS.

Vendor could suggest changes require in the item execution with Photographs on mail, but the execution should be done only after written approval on mail from EMRI GHS authorized person.

Vendor has to strictly adhere the item execution as per Job card assigned/ given by EMRI GHS (That is replace part need to be replaced not repair or execution without approval), if any discrepancy found then no amount would be paid for the same part.

**4. Delivery / Supply schedule:**

The work being to be carried out on existing operational Karuna Animal Ambulance unit, the down time for refurbishment/modification work needs to be kept minimum to support the 24x7 life saving core activity of EMRI GHS Gujarat. It requires close coordination for withdrawal and redeployment of ambulance from field along with effective logistics coordination between EMRI GHS and the vendor.

The successful bidder will be supplied Karuna Animal Ambulance Unit to be refurbished/modified as per the tender terms at their works. The details of work to be done will be given along with the Work Order and the job should be completed within 10 days from the date of receipt of the ambulance vehicle along with Job card.

The material used for the refurbishment should be of specified grade as stated in the tender, EMRI GHS representative has right to check the invoices and material any time during or after completion of job.

All materials needed for the completion of work is whole sole responsibility of the vendor, any delay due to non-availability of the spares would not be entertained.

- 5. Re-Allocation / Cancellation of tender:** In case of failure or on the part of the successful tenderer to fabricate and deliver the vehicles with in the stipulated date mentioned in the purchase order, EMRI GHS may cancel the purchase order in full, or part, and re-allot the same to next lowest tenderer who otherwise fulfills all conditions **and any extra expenditure involved due to this change will be recovered from vendor's deposit/outstanding/available dues/EMD/Security Deposit.**

- 6. Order Quantity:** The actual order quantity may increase or decrease as mentioned in tender quantity; the delivery schedule will be amended keeping the same time lines in the Purchase Order for increased quantity. The tender Quantity may be divided among multiple vendors in case of need.

**7. Liquidated damages for late delivery:**

- 7.1** EMRI GHS will levy/deduct for delayed fabrication of ambulances, a penalty of Rs. 1,000/- per unit per day on successful tenderer, who is given the purchase order, and who fails to deliver the fabricated vehicles as per the delivery schedule. The maximum L.D. for delayed supply will be charged within a ceiling of 10% of PO value.

A. Penalty for Rs 1000/- per Vehicle per day Up to 7 delay days

B. Penalty of Rs.2000/- per vehicle per day between 8 To 15 delay days

C. Penalty of Rs.3000/- per vehicle per day between 15 To 30 delay days

D. Beyond 30 days PO may be cancelled and PBG will be forfeited at the sole discretion of EMRI GHS.

- 7.2** Once the maximum price reduction is reached, termination of the contract may be considered. Non-performance of the contract provisions shall make



the successful bidder liable to be disqualified to participate in any tender for the next 5 years, in addition to forfeiture of Security Deposit and other penal actions.

### 7.3 Alternative Purchase

If the successful Bidder fails to execute the order within the stipulated time; the Tender Inviting Authority will be at liberty to make alternative arrangements to complete the work for which purchase orders have been placed from any other source or from the open market, at the risk and cost of the supplier. This would be in addition to any other penalties including forfeiture of security deposit.

8. Any damage observed in base vehicle during fabrication work needs to be get repaired by vendor through authorized dealer of vehicle manufacturers at his own risk and cost otherwise this repair amount will be deducted from their bills/outstanding and actual date of delivery of vehicle will be considered after this satisfactory repairs only.
9. Stage inspection and Pre-Delivery Inspection: Stage wise inspection will be carried out by EMRI GHS and after final inspection at works of the vendor vehicles will be delivered to EMRI GHS.
10. **Payment terms:** The payment against supply of stores shall be made **within 30 days** subject to availability of fund from the date of receipt of the goods in good and acceptable conditions at the destination along with clear receipt of Invoice. However, no interest will be chargeable by the vendor, if the payment is delayed.
11. **Performance Security Deposit:**  
The successful bidder, shall be required to submit **Performance Security Deposit of 5% of the order value** in the form of Demand Draft/Performance Bank Guarantee in favor of "EMRI Green Health Services, Gujarat", payable at Ahmedabad valid for a period of 14 months from the date of completion of order. The Bank Guarantee shall be returned on completion of the Warranty period of the goods supplied. However, if the supplier fails to execute the order or fails to perform the services as per contract, in addition to other penal actions, the Bank Guarantee shall be en-cashed & the amount forfeited.
12. **Liability of EMRI GHS:** As the payment against the supplies under this agreement will be made by EMRI GHS on behalf of and upon release of funds from respective State Government, It is expressly understood and agreed by, between the SUPPLIER and the EMRI GHS that the EMRI GHS is entering into this Agreement solely on behalf of respective State Government. In particular, it is expressly understood and agreed that though the respective State Governments / Government of India are not a party to this Agreement and have no liabilities, obligations or rights hereunder, any delay in the release of vendor payments, for the supplies made under this tender, solely depend on timely receipt of funds for the same from the respective state governments. The SUPPLIER expressly agrees, acknowledges and understands that the EMRI GHS is not responsible for any delays in the release of funds from respective state governments for what so ever reason it may be and shall not hold EMRI GHS responsible for delayed payments and EMRI GHS shall not be liable for any acts, omissions, commissions, breaches or other wrongs arising out of the contract. Accordingly, the SUPPLIER hereby, expressly waives releases and foregoes any and all actions or claims, including cross claims, impleader claims or counter claims against the EMRI GHS arising out of this Agreement and not to sue EMRI GHS for any reason, as to any manner, claim, cause of action or thing

whatsoever arising of or under this Agreement. However, EMRI GHS will persuade with respective State Government to enable the timely payment to respective Supplier

13. **Ethics:** Any attempt by a tenderer to obtain confidential information, enter into unlawful agreement with competitors or influence the committee or the Contracting Authority during the process of examining, clarifying, evaluating and comparing tenders shall make the tender submitted by that tenderer liable for rejection.
14. **Jurisdiction:** All disputes arising out of or in connection with this tender shall be referred to courts with Ahmedabad Jurisdiction only.
15. **Power of Cancellation:** EMRI GHS reserves the right to cancel the tender notification and reject any or all the tenders, at any time during the process of receipt, evaluation, and finalization of tenders, without assigning any reason what-so-ever.
16. **Ownership of tenders:** All designs, drawing submitted remain property of EMRI GHS.
17. **Force Majeure:** If at any time during the validity of the Contract, the performance in whole or in part by either party of any obligation under this Contract shall be prevented or delayed by reasons of War, Hostility, Acts of Public Enemy, Civil Commotion(s), Sabotage, Fire(s), Flood(s), Explosion(s), Epidemic, Quarantine Restrictions, Acts of State or Acts of God, hereinafter referred to as eventualities, then the Contract period will get extended for the period of Force Majeure, provided Notice of the happenings of any such eventualities is given, supported by a certificate of appropriate authority or Chamber of Commerce by either party to the other within 15 days from the date of occurrence thereof. Neither party shall by reason of such eventualities be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non performance or delay in performance. Work under this contract shall resume as soon as practicable after such eventualities have come to an end or ceased to exist and the decision of the Company as to whether the work has to be resumed shall be final and conclusive. Should one or both parties be prevented from fulfilling their contractual obligations by state of Force Majeure lasting continuously for a period of at least three months, the parties shall consult each other regarding further continuation of the Contract.
18. **Fraud & Corruption:**

The bidders, suppliers and contractors shall observe the highest standard of ethics during bidding and during performance of the contract. For the purposes of this provision, the following acts shall be considered as corrupt and / or fraudulent practices.

  - “Corrupt Practice” means offering, giving, receiving, or soliciting directly or indirectly, of anything of value to influence the action of an official in the procurement process or in contract execution.
  - “Fraudulent Practice” means misrepresentation or omission of facts in order to execution of contract.
  - “Collusive practice” means a scheme or arrangement between two or more bidders, with or without the knowledge of the purchaser, designed to establish bid prices at artificial, non-competitive level.
  - “Coercive Practice” means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in a procurement process or in execution of a contract.



During the process of evaluation of a bid or proposal for award of a contract, if it is detected that a bidder directly or through agent has engaged in corrupt, fraudulent, collusive or coercive practice in competing for the contract in question, then a) the bid shall be rejected and b) declare the firm ineligible for a specific period or indefinitely to participate in a bidding process.

In the bid document itself, an undertaking from the bidders may be obtained in the format.

**19. Saving Clause**

No suit, prosecution or any legal proceedings shall lie against Tender Inviting Authority or any person for anything that is done in good faith or intended to be done in pursuance of tender.

**20. Arbitration Clause:** In case of any dispute, the decision of COO EMRI GHS Gujarat will be final and honored.

**21. Termination:**

**22.1** EMRI GHS reserves right to terminate this contract without cause by issuing 30 days prior notice to supplier.

**22.2** The supplier may also terminate this contract by issuing 60 days prior notice to the purchaser, however, there shall be no termination by supplier within initial six months of this contract.

**Annexure-V**

**Material Description under Scope of Refurbishment:**

**1. Steel and Ply Wood Cabinet for storing medical equipment /place for Microscope / supplies / Wash basin / Dust bins:**

- Dimensions: length to cover the width of fabricated ambulance end to end Width = 1650mm, length 500 mm along the length of the ambulance and height=900mm.( Cabinet height 500 mm and the oxygen cylinder compartment height 400mm ) Placed alongside the partition wall behind the driver's compartment. Made of BIS quality water proof and fire retardant ply boards of Walls, Top and Bottom plywood thickness-19mm Drawers plywood thickness-12mm
- It should be gladded with 0.8 mm thick stainless sheet (SS-304) from all the areas exposed to patient compartment sides.
- Also all the other areas (drawer walls, sides, rear and bottom) exposed to air should be laminated with minimum 1 mm heavy duty mica of silver gray color. All the Sizes of the drawers should be as per Drawings supplied.
- Height of the cabinet-500mm (from above the oxygen compartment) Width of the cabinet-1650mm (From left wall to Right wall of the body)
- First lane drawers-width-400mm , height-200mm and Length 500mm ( three in no)
- Second lane drawer-width-400mm, height -300mm and Length 500mm.( three in no)
- The wash basin and dust bins to be covered with single opening door for removing and placing bins along with the water tank easily for cleaning and other purposes.
- All the hardware like rails, channels, sliders, locks, catchers, hinges, handles should be best quality of imported material only (e.g. HETTICH) heavy duty renowned brands.
- The drawers should be provided with double Magnet catchers for each drawer at back side to secure them against unintended opening during motion of the ambulance 9 slots of ABS material removable partition tray with THREE partitions to be provided in the upper drawer beside the dust bins and rest all top drawers to have 3 horizontal partitions. Two Concealed Portable Steel Dust Bins to be fixed with at least two screws there by making immovable with spring loaded lids for waste disposal are to be provided under the wash basin. 400mm Height (Including spring loaded lid) X200mmDia. Pilot cabin partition frame to be fitted with a sandwich FRP panel fastened to the MS frame form both sides.
- The Wash Basin Pump should have water tap positioned so that by washing hands water should not fall outside of the pot. Provision for Liquid hand wash carrier fitted on to the right side of the wall near wash basin with sufficient reinforcement.
- Fresh Water Tank and Drain Water Tank both made of 3mm thick food grade plastic quality with inlet and outlet - one below the wash basin and the second behind the codriver seat both having 18 Liters capacity. Drain water tank should be a closed circuit without overflowing to ensure fool proof draining by users. Proper space to be

provided in fresh water tank for replacement of washbasin pump.

- Wash basin and Drain water tank hose connection joints to be fixed firmly with clamp and sealant to prevent water over flow into the patient compartment.
- Both the Tanks should be easily removable for any sort of Maintenance and Cleaning purpose.
- A heavy duty Motorized Pump (12 V AC power operated ISI mark submersible) with foot operated control, to pump the water from the fresh water tank.

**2. Squat bench / attendant and Helper seat- (with Seat belts) with storage for EM rescue tools.**

- I. Along with Left wall the squat bench to be installed (on LH wheel hump). The bottom of the seat to be mounted on 4x50X50 mm size MS angles with bolts  
  
fitted to heavy duty hinges at three places. Such hinges should be along the seat length. These heavy duty hinges are to be placed at equidistance. All the bolts should be mounted on the reinforcement given to seat.
- II. A minimum 50mm thick, 50 or higher density Foam cushion such as bucket  
  
seat to be provided on 12 mm water proof and fire retardant ply board for comfort. The same should be Upholstered top, side and bottom with non absorbent Rexene of silver gray color properly fastened.
- III. The seats to be open able type to lift and place the equipment or tools inside the seat bench
- IV. The back rest of the seat should be made of 12 mm water proof and fire retardant ply wood with 25 mm thick and 50 mm density foam cushion. The seat has to be fastened to wall as well as the pillars of the body structure for firm grip. The size of the cushion seat is 900mm length, width 400mm and 150mm height. The same should be Upholstered top, side and bottom with non absorbent Rexene of silver gray color properly fastened.
- V. Dimensions of the Seat bench: Length = 850mm, Width=400mm. Height = 470mm. The inner box area should be covered with the 4mm thick black color Heaton sheet properly glued to the inner surface of the bench.
- VI. The seat bench to be made of FRP (min 4 mm) outside and with the Mild  
  
steel (MS) flat 32X4 mm thick frame reinforced within, to carry 500 kg weight and to be painted with PU paint.
- VII. Re enforcement to seat bench has to be given in equal distance for storage of tools and accessories.
- VIII. The floor joints to be sealed with silicon paste sealant to prevent water seepage into



the storage area. Four suitably placed good quality seat belts are to be provided with proper reinforcement on top and bottom.

- IX. A stopper to be provided for holding the Squat bench in opening position at rear end (from entrance side) of the Squat bench in 90 degree position with proper reinforcement. Velcro to be provided for holding the bottom on to the back rest.

### **3. Doctors seat and table**

- i. A doctor's table to be provided along the left wall adjacent to squat bench. The table to be made with dimensions such as 400mm L x 400mm Wx 700mm height . The storage box drawers dimensions, bottom drawer - 400mmLx 400mm Wx300mm H, the middle drawer 400mmLx 400mmWx 250mm H and the top drawer with 400mm Lx 400mm Wx 150mm H.
- ii. A seat for the doctor is to be provided adjacent to the table for sitting and can use the table for writing purpose.

### **4. Storage Compartment :**

- a. A door for the Trolley to be cut (as per drawing) and fabricated with bonnet type locking with a opening lever in the driver compartment.
- b. The Door opening lever should be below the driver seat with flexible wire cage which is firm and flexible without steep bend en route.
- c. The Cylinder compartment should be properly sealed from all sides along with the Door side to protect and avoid any chances of dust entering this compartment. Rubber beading to be provided on compartment (door seating area).
- d. Humidifier Bottle: Poly Carbonate Bowl with metal Cap and T type inlet outlet nipples, 2 nos. All the connectors should be of chrome plated on brass material.
- e. Flow Meter: Brass with chrome plated body, Poly carbonate tube, to regulate the flow from 0 to 15 liters per mints. It should be a back pressure compensated.
- f. Humidifiers should be mounted @1100mm height from the floor on RH side wall in front of the wooden cabinet.
- g. Three plus one (3+1) four ports of Brass 3/8 inches nipple in size be provided in complete one assembly (One set) on a common rectangular Brass Tube (Rail) with two Needle Valves at both the ends.

### **5. Examination table**

- An examination table to be put over the hallow rack with the dimensions of 1800mm L x 700mm w at 700mm height. The examination bench to have supports in between the storage boxes to take up the weight of 150 kgs minimum.
- The rear side of the hallow box over the storage box to be kept open .



- The Examination table to be covering the storage box area as well the rear hump area up to the right side wall. The area which covering the hump width can be made as folding type for taking the items and keeping in the storage at hump area.

## **6. Flooring**

- i) A water proof and fire retardant marine ply board with 15 mm thickness automobile grade IS: 15061-2002 or 5509:2000 approved, preferably Magnus Chequered plywood IS: 315:64:2010) is to be used for flooring with maximum two joints coming around the center of the body. The flooring should be provided with antirust coating before start of the flooring work.
- ii) A non static, mark resistant, scuff proof and safety flooring material LG-CS301 or Veekay or Wonder floor 1.6 mm product code 554902 or EQUIVALENT APPROVED BY TECHNICAL COMMITTEE) to be glued properly without entrapped air bubbles and without any joints anywhere.
- iii) All floor level moldings, edging and trim shall be sealed to prevent fluids from seeping under cabinets, walls and ply board.

## **7. Interior paneling work:**

### **a. Wall panel**

- i. Complete interior paneling of the 02 sidewalls, both sides of the partition wall between patient cabin and driver cabin, roof of both patient and driver cabin & back door panels should made from Fire Retardant grade FRP sheets of minimum 03 mm thickness.
- ii. Adequate provisioning to be made in the FRP Panels for open able glass sliding windows.
- iii. The complete interior should be edgeless and suitable for easy cleaning / scientific fumigation / treatment of disinfectants. The panels must be suitably formed using the appropriate FRP processing technology so as to match to the contour of the vehicle and looks aesthetically pleasing.
- iv. The panels for each of the surfaces should be produced as modular with minimum joints either along the length or the width of the panels to accommodate future repairs and maintenance works. The approval of client is required before execution of work regarding the paneling layouts. The quality of joint should be homogeneous to suit the hygiene requirements of MHU compartment; all the joints should be tool based for aesthetics.
- v. The minimum thickness at any point of the panels should not be less than 3 mm. The ceiling, both the sidewalls, both sides of the partition wall should be produced in one single piece matching to the dimension of the patient compartment dimension of the ambulance.
- vi. Between the interior conversion panels and the internal surface of the base vehicle body there should be adequate insulation of appropriate grade to have a good climatic control environment inside the vehicles.
- vii. The FRP panels are to be reinforced with steel rib cage and all Interiors, internal sides, cover to close the wheel hump and roof should be paneled in **Fire Retardant Fiber Reinforced Plastic** (FRP) minimum 3 mm thick, Chopped Strand Mat / Isophelic Polyesters / Gel Coat (Naphtha / Saint Gobin or equivalent) with superior quality PU PAINT SWAN WHITE COLOUR in painting. Anti corrosive plating is necessary for the cage
- viii. Gap between the FRP sheet and the vehicle body should be stuffed with PU foam (Minimum 30 mm thick) sheets to reduce the heat transmission.
- ix. Patient compartment, insulating material should be non-toxic, non-settling type, vermin proof, mild dew proof and non hygroscopic body and paneling to be provided

- x. The joint of one panel to the other must be suitably engineered so that all the joints are functionally hygienic and protected from any ingress of liquids and any other medical secretions of any kind. The joints should be finished in such a way so that these appear aesthetically appealing.
- xi. The panels should be molded keeping in view the aesthetic aspect for electrification and other fitments as per utility and layout of the patient compartment.
- xii. There may be minor variations in the mentioned dimensions of various storage, seating and other fitments depending upon the actual space available in the rear compartment of base vehicle. In such cases, any deviations need to be processed under approval of EMRI GHS technical team.
- xiii. The material specified for interior paneling is Fire Retardant grade FRP of white color.
- b. All the Panels, Equipments & storages Mounted and Provision for Medical Equipments to be Mounted, shall have 4 mm thick Mild Steel (MS Fe 410) sheet reinforced behind the specified area.**

The MS sheet should be MIG welded to the body of the Vehicle structure as per Automobile standards and **be anti corrosive plating and coated with Primer to avoid any rusting.**

- c. Partition wall:** Partition wall: cold rolled 40X20X0.8 MM MS rectangular hollow tubes should be made a frame structure to hold the partition walls of 3 mm FRP sheets on both sides of the tubical structure. Partition wall has to be PU painted on both sides.
- d.** A seamless appearance and finish is desirable to keep the ambulance bacteria free in services.

## **8. General Criteria:**

- i. Gap between the FRP sheet and the vehicle body should be stuffed with PU foam (Minimum 30 mm thick) sheets to reduce the heat transmission.
- ii. Provision for placement of electrical switches/sockets/fans/foldable seats to be made available with the FRP panels as per placement details and dimensions provided.
- iii. Provision for I.V hooks & holders 2 nos. should be made on the ceiling just above the storage -3(Patient examination bed).
- iv. Pilot cabin roof should be made of FRP with full length of hatrack above the sun visor to carry material.

## **9. Head- racks and grab rails in the ceiling**

### **a. Head Racks:**

- v. 2 nos. Headracks figure (9/10) for storage to be provided in the MHU, please refer drawings for position and measurement.
- vi. Made in FRP (min 3mm thick) and required Powder coated MS reinforcement to be provided. Inner surface is to be pasted with soft heatlon sheet of 4mm thickness. Anti corrosive plating should be given to the reinforcement plate and coated with primer and paint
- vii. The Head rack should have suitable closures to cover the opening which are easy/comfortable to operate and do not have any sharp edge at the openings.

**b. Grab Rails:**

- i. A 2040 mm long pipe of 30mm dia. made of stainless steel (SS) be placed as grab rail on the Ceiling with proper supports at four places.
- ii. 2 nos; 610mm long pipe edgeless grab rail of 30mm dia. made of SS is placed as Grab Bar one near the LHS rear door at Storage cabinet Figure (2) and other at the LHS wall beside LHS door, with firm support at the ends.
- iii. The grab rail should have capacity to withstand pulling force of 200 kgs.

**10. Fire extinguisher mounting:**

A proper heavy duty bracket support (powder coated on MS structure) should be provided beside storage 1 for placing a fire extinguisher.

**11. Water Dispenser:**

A water Dispenser of 4.5 Liters capacity is to be provided above washbasin area with appropriate fixing bracket and Velcro for safety during movement of vehicle.

**12. Scope of Fabrication (Electrical) Work:****1. Inverter:**

- i. True sine wave Make- M/s Luminous (1050) VA inverter is preferable as a standardized equipment for all our ambulances.
- ii. Inverter Capacity - 900 watts / (1050) VA,
- iii. Input Range - AC 180 V – 250 V / DC 10.8 V - 14.1 V
- iv. Frequency - 50 Hz
- v. Power Factor - 0.8
- vi. Output Voltage – 220(+/-)10% (regulated output from full charge battery voltage to low charged battery voltage)
- vii. Waveform - Single Pulse PWM
- viii. Efficiency - 85%
- ix. Charger - Heavy duty CC/CV type with current limit at 12A with wide input range (150V-270A)
- x. Integrated AC/DC supply inside the vehicle synchronous with alternator.
- xi. All the electrical Wiring should be done in consultation with the Inverter Manufacturer's recommendation, and should provide certification to prove this.

**2. Internal lights, sockets, switches and other electrical equipments:**

- i. (4Nos) Power LED automotive light fixtures for internal lighting from authorized and reputed light manufactures only and built in 12V DC powered, each on a separate circuit. Approved by EMRI GHS.
- ii. 220V AC / 5 amp - 3 pin (8 Nos) and 12V DC-Round sockets (3 Nos) power source with. Crabtree or equivalent modular switches.
- iii. The position of Switch & Socket assembly would be near tables & patient examination bed.
- iv. External charge port with spring loaded lid. Has to be located under pilot seat.

- v. Separate switches to be provisioned for individual lights, fans, LED TV and individual sockets.
- vi. All the electrical cables are to be off minimum 04 mm dia (Flexi Cab, Finolex , Shanko deluxe with ISI marked). All the female sockets are to be of 05 pin 06 amps. All the electrical cabling are to be done inside the FRP side wall with appropriate PVC routing boxes for easy repair facility.
- vii. All Two AC 08 inch fans are to be placed/mounted at the following locations each one at each location;
  - 1. Just above the Storage-3(Patient examination bed)
  - 2. Just above the storage-2 (Patient examination bed)

### **3. Electrical Wiring:**

- i. All The main Components like,
  - a. Each of Internal Lightings (LED Lights),
  - b. Each of Equipments power Sockets,
  - c. All four AC fans
  - d. Inverter & its charging port
- ✓ AC& DC wiring to be routed separately with reasonable gap to avoid short circuit. The Socket plugs of AC and DC to be fixed separately with minimum 6 inches gap in between. All the plugs are marked on top of it whether it is AC Plug or DC plug
- ✓ Should have separate circuits, (Power drawn directly from source with proper cut off switch after Battery/Inverter) and a MCB of 05 amps (Havells) on it.
- ✓ Fuse rating and usage should be mentioned on Fuse box cover.
- ✓ A laminated copy of standard wiring diagram should be provided with each ambulance for reference.
- ✓ The position of lights, Fans, Fuses, MCB, Switch board & Socket assembly should be preapproved by EMRI GHS.
- ✓ All switches and sockets must be of Havells/ Crabtree or equivalent modular switches make.
- ✓ Other than vehicle wiring harnesses, all wires/harness used for should be minimum 4 MM dia ((Flexi Cab, Finolex , Shanko deluxe with ISI marked) .
- ✓ All fans must be of Remi make.
- ✓ All MCBs must be of Havells/Crabtree make.
- ✓ The LED lights must be from reputed brand and must carry 01 years onsite repair/replacement warranty.
- ✓ **All above items must be ISI marked were available and should get approved by EMRI GHS prior to fitment.**
  - ii. A separate MCB to each of the (as mentioned above) circuits be given.
  - iii. There should be an Indicator mark on each MCB and fuse box to identify the circuit configuration.
  - iv. There should not be any joints be given within the Circuit Wiring,
    - v. At any unavoidable wiring junction(s) the wires should be joined through Bakelite Connectors only,
  - vi. There should not be any loose wiring and loose joints;
  - vii. All the electrical accessories should carry ISI Mark and be approved by technical committee and should be of (ARAI/ISI) automobile standards.
  - viii. All other unspecified Parts necessary for the Wiring should be of Automobile grade and/or ISI Certified.
  - ix. Fitment of battery and their connections to it shall be such as to prevent any possibility of inadvertent short circuits.

**13. Collapsible canopy:**

A collapsible canopy, manually operated, to be installed on the LHS external sidewall with heavy reinforcement. The installation area should be just below the roof and above the roof water channel. The material specification for the collapsible canopy is as mention below;

- a) The frame of canopy will be of anodized aluminum bars.
- b) The canopy material will be of Ferrari fabric or its equivalent approved by EMRI GHS
- c) The canopy and the material used to be presented to EMRI GHS technical team for pre-approval before installation. Decision of EMRI GHS will be considered final.
- d) The dimensions of the collapsible canopy will be L-12 Fit x W-08 Fit when in open condition.

Minor changes may be recommended by EMRI GHS with the dimensions, material and installations specified. The selected tenderer must obtain written approval from EMRI GHS technical team before implementation of such changes recommended at later stage. No additional cost can be provisioned for such changes by the tenderrer.

**14. Quality of Material :**

- All the materials used in fabrication should be only of brands mentioned in the tender, the equivalent product could only be allowed in case of unavailability of specified product and it should be approved by EMRI GHS Technical authority.
- Any use of sub standard material not meeting the specifications will result in penalty and cancellation of purchase order whatever is found feasible to EMRI GHS.
- Vendor will have to produce the purchase invoice copy, routine test certificate, batch production quality check certificate and dealership authorization certificate of all the key specified items in the tender used in fabrication if asked by EMRI GHS for verification of source and quality of materials used in view of tender specifications.
- Interior layout could be changed during the fabrication process for better utility of the ambulances as and when desired and as approved by EMRI GHS.

## **Annexure VI**

### **Body Graphics:**

The external graphics will be a combination of 3M vinyl and radium material. The tenderer should quote the price for Radium Branding including Labor and all taxes. None of the radium stickers are to be pasted directly on vehicle body. All are to be pasted on vinyl base. Detailed drawing/samples will be furnished. Ambulance to be supplied with exterior design / painting as per EMRI GHS design. All vinyl / reflective stickers/ films of LG, 3M or equivalent to be used. CDR

## **Annexure VII**

### **WORKMANSHIP CRITERIA FOR ACCEPTANCE**

(General appearance of the vehicle shall not show any evidence of poor workmanship).

The following shall be reason for rejection:

- 
1. Rough, sharp or unfinished edges, burrs, seam, sharp corners, joints, cracks, and dents.
  2. Non-uniform panels. Edges that are not filleted, beveled, etc.
