## BRIEF NOTE ON THE GPS REQUIREMENT

This document contains General Terms and Conditions, including desired and Mandatory features, qualification criterion, Commercial terms and conditions that are followed by EMRI Green Health Services for supply of GPS devices. However, the terms and conditions are not binding on EMRI GHS, TN and liable for change without any notice.

For and on the behalf of Health Department, EMRI GHS, TN floats this Online eTender for fixing the rate contract for GPS devices. The contract for the requirement pertaining to TN-EMRI will be entered into by TN EMRI directly. For the requirement pertaining to other departments, the respective departments will enter into contract as per the Terms & Conditions of the Tender.

This tender is called for, for fixing the unit rate for providing GPS facility for a period of **2 years** on rate contract basis. The tentative quantity for the rate contract period is expected to be around 2971 units. However, the actual quantity will be based on the request of the individual departments and the quantity is only tentative. The bidder will not have any right on the increase and decrease of the actual quantity and should execute the contract at the rates and terms and conditions irrespective of the actual quantity.

These GPS will be installed in vehicles which are assigned specifically for Health Care Programs such as Emergency Service, Mobile Medical Units/ Hospital on Wheels, Vaccine Carriers, Inspection Vehicles etc., as per the needs of respective Department.



## **General brief about EMRI Green Health Services 1-0-8 operations:**

EMRI Green Health Services (formerly GVK EMRI) is a pioneer in Emergency Management Services in India. As a not – for – profit professional organization operating in the Public-Private Partnership (PPP) mode, EMRI Green Health Services is the largest professional Emergency Service Provider in India

EMRI Green Health Services operates 1-0-8 ambulances through a Emergency Response Centre at head office (currently 108 operations in 12 states & 1 Union Territory). Victim in Emergency dials toll free 108 number and upon receipt of call, the call center employee dispatches the nearest available ambulance to the scene/location of emergency. The Emergency Medical Technician (EMT) provides pre-hospital care to the victim at the scene followed by shifting of the emergency victim to nearest hospital. The ambulance is equipped with a variety of medical equipment, medical consumables and disposables to ensure the victim is stabilized (pre-hospital care) by the time the ambulance reaches the hospital for further treatment. Once the patient is handed over to the hospital, the ambulance returns to its pre-designated base location and is ready for attending next emergency.

### **Objectives of GPS:**

To track ambulance on real time basis to ensure visibility and GPS Tracking.

### **Definition:**

GPS tracking device with GPS and GSM/GPRS Modem which transmits the Latitude Longitude along with vehicle Identity and few other parameters at a designated frequency in real-time. This would have ports which capture the vehicle parameters like Ignition (engine on/off status), speed etc.

### **Bid Process:**

- EMRI GHS, TN calls for bids from all reputed Global Position Systems (GPS) systems solution-providers/manufacturers/their authorized dealers for supply, installation, commissioning and maintenance of GPS devices in 108 Emergency Service Ambulances, 155377 FHS, 102 JSSK, RBSK, Tribal, NCD and MMU across Tamil Nadu.
- All the prospective bidders are requested to kindly go through the “terms and conditions” of the “TENDER” document and submit their bids in e-Tender accordingly.



- The tender document is available for free download in the website of <https://tntenders.gov.in/> and EMRI Green Health Services (www.emri.in) at a free of cost.
- Any noncompliance of TENDER terms and conditions by the bidder shall automatically result in the forfeiture of EMD/PBG.

### General Terms and Conditions

#### **1. Eligibility criteria of the Vendor:**

- i.** Any reputed Automatic Vehicle Location and Tracking (GPS) systems solution-providers/manufacturers/their authorized dealers are eligible to participate in the TENDER.
- ii.** The GPS unit and Solutions offered by the Bidder should comply with existing Motor Vehicles Act and Rules and should be adaptable for modification in case of amends in the rules during the contract period. The unit should comply and satisfy relevant AIS 140 specifications, if any other document issued.
- iii.** The participating bidder must have cumulative average annual turnover of at least Rs.2 Crore during last three years from activities related to GPS.
- iv.** Only those bidders who can provide support in Tamil Nadu, with service network across Tamil Nadu need to participate.
- v.** Bidder/OEM manufacturers should have the operational experience since last three years in GPS business.
- vi.** Proof to be submitted at the time of preliminary bid evaluation on the presence of field service network or an undertaking needs to be given as per Annexure-9 attached.
- vii.** Bidder/OEM manufacturers having installed at least 300+devices and running as on date within the last three years of TENDER evaluation only need to participate. Purchase order copies should be submitted as proof.
- viii.** Experience in Government projects /a reputed organization and approval by Transport Authorities of any State in India are preferable.



- ix.** A firm/Group are allowed to submit only one proposal. In case they submit or participate in more than one proposal by any group all the proposal submitted shall be disqualified.
  - x.** Should enclose the GST registration certificate and PAN card.
  - xi.** Sample to be submitted before tender closing date 11.06.2026.
  - xii.** Bidder should be in the listed in Approved VLTD Manufacturer in TN-RTO
2. GPS specifications, Features, Operational Requirements-Annexures-7 & 8
3. **Scope of delivery:**
- I. The delivery scope for the selected vendor would include the following: -
    - i. All supplied hardware to be installed on ambulances. Power outputs and location for fitting the device etc will be indicated by EMRI GHS / other departments in health.
    - ii. Server-side configuration at TN-EMRI.
    - iii. Commissioning of the device and assisting TNEMRI team in getting the data from the ambulances onto the server
    - iv. On field after sales support.
4. **Service Terms:**
- I. The service provider should always keep 10% of buffer stocks ready to replace the faulty devices without loss of time.
  - II. Future software upgradation: Any upgradation in the software in the GPS devices supplied by the supplier/vendor must be provided free of cost during contract period and should comply with any amendments in Motor vehicles act, rules and regulations.
5. **Service Level Agreement/SLA:**
- I. After service support: All calls for support will have to be attended by the selected vendor within 3 hours of registering of the complaint by TN EMRI either through phone or e-mail.
  - II. Escalation Matrix: for attending the service related/any other issues needs to be provided by the vendor at the time of bid submission.
  - III. Resolution & Replacement of faulty devices: Reported issues would need to be resolved by the selected vendor ONSITE within 24 hours of registering of the complaint. Resolution in this context means



“replacement with a new device” or repair to the satisfaction of TNEMRI, whichever is earlier.

IV. Date and Timing of installation would be informed by TNEMRI and vendor has to strictly adhere to the schedules as installation of devices in the ambulances/Vehicles has to be done only when emergency transportation of cases/field activity are relatively low (preferably during night time or early morning hours).

V. Penalty: Replacement / troubleshooting of faulty devices should be replaced / rectified within 24 Hours, else penalty of Rs.1000/- per device per day will be applied from 2<sup>nd</sup> day onwards.

## 6. **Evaluation Process:**

Tender will be evaluated in three stages:

### a. **Preliminary evaluation:**

- ❖ All bidder are requested to strictly submit the documents in sequence as per preliminary evaluation criteria.

### b. **Technical evaluation**

- ❖ A procurement committee comprising members from TNHSP/TN-EMRI/ other assigned Technical Consultants will evaluate.
- ❖ TN-EMRI may at its sole discretion add/delete/revise any of features at any stage of tender evaluation due to administrative reasons.
- ❖ All bidder who meet the preliminary criterion, and submit technical bids conforming to the technical evaluation criterion only will be eligible for commercial evaluation.
- ❖ TN-EMRI shall consider the information furnished by vendor on technical requirements as sufficient and qualify the vendor for price bid opening. If, at any stage of pre-supply and post supply period, it is found that any information furnished by the vendor is either false or hidden or fabricated, such vendor may be blacklisted by the Government and prohibited from participating in any of future tenders.
- ❖ Sample Evaluation: Sample device provided will be inspected by the committee in front of suppliers and the same device will be installed for sample study to understand the work efficiency of the device.
- ❖ Field Testing: In the process of technical evaluation 10 devices of each technically qualified vendor will be installed in 10 different vehicles related to TN EMRI for 15 days and the performance of the device will be validated by monitoring the performance in dashboard.
- ❖ The bidder should submit GPS Device should work with 4G network. Primary device should be in 4G network. If there is no 4G, the device should auto fall back to 2G network and work on 2G. For technical



evaluation the participating bidders should submit 10 GPS devices for 10 Vehicles with 4G network. AIS140 Device.

### **C. Commercial evaluation:**

- ❖ Commercial Bids of the bidder, who qualify in the Technical Bid Evaluation, will be opened. L-2 and other qualified bidder will be contacted only if L-1 vendor fails in the delivery schedules, installation, maintenance and any other tender terms and conditions.
- ❖ Price bid will be opened for those bidders who have technically cleared the field testing. Price bid will be opened only after technical evaluation.

### **7. Pre bid meeting:**

- ❖ Only two persons per company will be permitted for the pre bid meeting and evaluation.
- ❖ All the bidder may seek clarifications only from the procurement committee on any of the TENDER terms and conditions either before or at the time of pre-bid meeting.
- ❖ All clarifications have to be taken at the time of pre-bid meeting only. No enquiries/clarifications will be entertained at the time of TENDER opening.
- ❖ All the minutes of the pre-bid will be documented and will become part of TENDER evaluation process. Decisions taken in the pre bid meeting shall supersede the relevant terms and conditions in the tender document.

### **8. SUBMISSION OF BID**

The Bid should be uploaded in E-Tender online with the required documents.

9. TENDER documents that do not provide complete information and documents sought for and that are submitted after the specified time will not be considered and will be summarily rejected. Bidder should quote their prices in the prescribed format given in this tender document.

10. TENDERS received in any other form will not be entertained and liable to be rejected.

11. Vendor should sign the "Declaration certificate" (as per Annexure-1) in their company letter head stating that they have read and understood, all the Terms and Conditions stipulated for in the TENDER, and are willing to abide by these TENDER terms and conditions", before submitting the TENDER



document. TENDERS submitted without the Signed declaration certificate will be considered incomplete and will not be considered.

12. The Bid should be properly page numbered, signed on each and every page and should be complete in all aspects
13. Place of inspection – All the evaluation and inspection will be done at the venue of TENDER opening i.e. TNEMRI at DMS Campus, Anna Salai, Teynampet, Chennai or at any other place that would be informed in advance to the bidder.
14. **Validity of the TENDER:**  
All bids/prices submitted shall remain valid for a period of two years from the date of opening of TENDER or until finalization of next tender whichever occurs later. It can be extended for another one (1) year based on the mutual agreement.
15. **EMD Amount:**  
The bidders shall make the payment of EMD online through the payment gateway provided in the TN-tender procurement portal. <https://tntenders.gov.in/> i.e., through State Bank of India Multi Option Payment System (SBI MOPS Gateway). The non-responsive / non-selected bidder, EMD will be returned back. EMD Exemption is applicable for MSME - Manufacturers within the State of Tamil Nadu – Copy of UDAYAM registration certificate should be submitted.
16. **Performance Bank Guarantee:**  
The successful Bidder shall submit within 15 days of release of Purchase order, a Performance Bank Guarantee value equivalent to 3% of value of order for 2 years calculation and valid for a period of two years. PBG has to be submitted within 15days of release of Purchase order from the concerned department.
17. **Price:**
  - 1.The price offered in the TENDER should be as per the structure requested in the BOQ and should be inclusive of all costs and taxes for delivery and installation, commissioning and maintenance (OPEX Cost) of GPS.
  - 2.The price quoted shall remain "FIRM" for the entire validity period and without any escalation whatsoever.
  - 3.The procurement Committee may at its sole discretion negotiate with the L-1 vendor to further reduce the prices; in case it is felt that L-1 prices



are more than prevalent market prices or any other reason in the interest of public in general.

**18. Installation, commissioning & maintenance:**

- a) Where ever required the vendor shall be responsible for shipping and commissioning the items to vehicles of TN-EMRI spread over the entire state of Tamil Nadu within 45 days.
- B) Successful vendor is also responsible for swapping between vehicles as per discretion of TN-EMRI during the contract period.

**19. Quantity allocation:**

- I. In an event of L-1 vendor unable to meet delivery deadlines due to any reason, TN EMRI will go to the next bidder strictly in the order of their original position of the price bid to match the original price.
- II. Successful bidder has to undergo Prototype evaluation process before release of purchase orders.
- III. All the quantity requirements shown herein are tentative and release of Purchase order will be as per the actual requirement of TN-EMRI according to needs.
- IV. During the period of the contract, if the price of any item is reduced due to any reason including any Law or Act of the Central/State Government, the vendor shall be statutorily bound to intimate the reduced rates immediately to the purchaser and shall charge the reduced rates. The purchaser is empowered to unilaterally effect such reduction as is necessary in rates, in case the vendor fails to notify or fail to agree to such reduction of rates. In case of sole vendor for any schedule, EMRI Green Health Services can either compare the quotes by the sole vendor with market prices and may negotiate further or scrap the TENDER and go for re-TENDER.

**20. Delivery / Supply schedule:**

- I. The successful vendor has to supply, install and commission and maintain the GPS as per delivery schedules to be given from time to time.
- II. Delivery & installation of devices: within 45 days from the date of PO release by TN EMRI and acknowledgment.

**21. Ethics**

- I. Any attempt by a Vendor to obtain confidential information, enter into unlawful agreements with competitors or influence the committee or the Contracting Authority during the process of examining, clarifying, evaluating and comparing TENDERS shall make the TENDER submitted by those Bidder liable for rejection/disqualification.



## 22. Indemnity

- I. The Supplier shall at all times indemnify the Purchaser against all claims which may be made in respect of the items, for infringement of any right protected by Patent, Registration of design or Trade Mark and shall take all risk of accidents or damage which may occur or failure of the supply from whatever cause arising. The Supplier shall be entirely responsible for the sufficiency of all the means used by them for the fulfillment of the contract.
  
- II. Supplier agrees to indemnify, defend and hold TNEMRI in health and its officers, directors, employees, agents, its parent, partially or wholly owned subsidiaries, franchisees, successors and assigns harmless from and against any and all liability, losses, damages, claims, liens, expenses or causes of action including, but not limited to reasonable legal fees and expenses that may be incurred by EMRI Green Health Services, arising directly or indirectly out of, or in connection with, Supplier's violation or breach of any of the terms of this Agreement or any act or omission to act by Supplier in violation of this Agreement. TNEMRI shall provide Supplier with prompt written notice of any claim for which indemnification is sought and shall have the right to participate in the defense of any such claim.
  
- III. TNEMRI agrees to indemnify, defend and hold Supplier and its officers, directors, employees, agents, its parent, partially or wholly owned subsidiaries, franchisees, successors and assigns harmless from and against any and all liability, losses, damages, claims, liens, expenses or causes of action including, but not limited to reasonable legal fees and expenses that may be incurred by Supplier, arising directly or indirectly out of, or in connection with, TN EMRI's violation or breach of any of the terms of this Agreement or any act or omission to act by TN EMRI in violation of this Agreement. Supplier shall provide TN EMRI with prompt written notice of any claim for which indemnification is sought and shall have the right to participate in the defense of any such claim.

## 23. Familiarity with the terrain and supplier performance:

- I. It is expressly understood that all the bidder/OEM are familiar with the geography/topography of the ambulance locations across Tamil Nadu and are satisfied that the devices and service that they are offering to TNEMRI



shall work satisfactorily as prescribed in the SLA. No claim from any of successful bidder shall be accepted on account of nonperformance citing reasons of bad connectivity or terrain related issues or any other issue, external or internal. Connectivity is poor or not available in some areas, it will be treated as exempted.

- II. It would be single responsibility of the vendor to provide the data in the desired format of TNEMRI for all the mandatory features. TNEMRI may extend any application support at its sole discretion, without any additional cost

**24. QUALITY ASSURANCE:**

Supplier represents and warrants that it shall fully comply with all written quality assurance requirements or instructions of TNEMRI, and as they may be amended from time to time in the sole discretion of TN EMRI. Supplier further represents and warrants that the Product shall be produced, manufactured, stored and shipped by Supplier in strict compliance with all applicable central, state and local laws.

**25. Trademarks**

Supplier shall not, without prior written consent of TN EMRI use the trademarks or service marks or sales marks of TNEMRI in any manner whatsoever, unless, and then only to the extent, such use is authorized by TNEMRI in writing and then only in accordance with TN EMRI's directions or specifications.

**26. Intellectual Property, Proprietary Knowledge and Confidential Information (Excluding the information in the Public Domain)**

- a. Supplier acknowledges that in connection with this Agreement, TN EMRI may disclose to Supplier, or Supplier may otherwise obtain or develop knowledge of certain confidential and proprietary information of TN EMRI, including, but not limited to, trade secrets, intellectual property, future business plans and services, financial, sales, Supplier, customer, employee, investor, or other business information related to the business and activities of TN EMRI.



- b. All such information is hereby designated by TN EMRI to be Confidential and Proprietary Information. Supplier acknowledges and agrees that Confidential and Proprietary Information shall not be disclosed by Supplier or any of Supplier's employees, representatives, agents or contractor's without the express written permission of TN EMRI. Notwithstanding the foregoing, Supplier, during the term of this Agreement, and in order to carry out its obligations under this Agreement may disclose Confidential and Proprietary Information to its EMPLOYEES solely for the purpose of performing its obligations under this Agreement, and only on a "need to know" basis. Supplier agrees that all of its employees receiving any Confidential and Proprietary Information shall enter into a separate written confidentiality agreement with Supplier that ensures the employee will comply with the confidentiality provisions of this Agreement. A copy of each such confidentiality agreement shall be provided to TN EMRI.
  
- c. All Confidential and Proprietary Information shall remain confidential until TN EMRI designates it as non-confidential or until the information becomes public through no fault of the Supplier.
  
- d. Supplier shall not be liable for the disclosure of Confidential and Proprietary Information if made in response to a valid order of a court or authorized agency of government; provided that fifteen (15) day's notice first be given to the TN EMRI so a protective order, if appropriate, may be sought by TN EMRI.
  
- e. Supplier agrees that in the event Supplier or any of its employees, contractors, representatives, or agents breach the provisions of this Article, such breach or threatened breach would cause irreparable harm to TN EMRI, and in such instance, TN EMRI shall be entitled to injunctive and other equitable relief to prevent such breach or to remedy any actual breach.

## 27. **Miscellaneous**

- a. The parties to this Agreement are independent contractors. Nothing contained herein shall constitute this arrangement to be employment, a joint venture, a partnership, a franchise or an agency between the parties.



Neither party has the authority to bind the other or to incur any obligation on its behalf.

- b. No waiver by either party of any default shall be deemed as a waiver of prior or subsequent default of the same or other provisions of this Agreement.
- c. If any term, clause or provision hereof is held invalid or unenforceable by a court of competent jurisdiction, such invalidity or unenforceability shall not affect the validity or operation of any other term, clause or provision, and such invalid or unenforceable term, clause or provision shall be deemed to be severed from the Agreement.
- d. This Agreement constitutes the entire understanding of the parties, and revokes and supersedes all prior agreements between the parties, and is intended as a final expression of their agreement. It shall not be modified or amended except in writing signed by the parties hereto and specifically referring to this Agreement.
- e. Bidder or employees of vendor cannot claim or construed as employees of TN EMRI.

**28. Compliance of the Laws of the land**

Supplier shall comply with all state and local laws and regulations regarding the Product manufacture and production, shall obtain all necessary licensing for the operation of its business and the production and manufacture of the Product, and shall further comply with all quality control standards promulgated by TN EMRI from time to time.

**29. Documentation requirements:**

Supplier has to send the following documents

- a. Invoice in original along with one additional copy, both duly signed and stamped by supplier
- b. A copy of Purchase order raised by TNEMRI.

**30. Product Withdrawal**

- a. If it is deemed necessary at any time by either TN EMRI or Supplier or any local, state, or central governmental agency or other authority to recall or



withdraw the Product produced by Supplier and being supplied to TN EMRI, either as a result of failure of the Product or Supplier to strictly comply with TN EMRI's quality standards or any governmental health rule or regulation, or shall fail to comply with any other governmental authority or agency having jurisdiction, supplier shall bear all costs and expenses incurred by it and/or in complying with the recall or withdrawal procedures, unless (attend only then to the extent) such recall or withdrawal is solely the result of the negligence or misuse by TN EMRI.

- b. If Supplier fails or refuses to promptly comply with the recall or withdrawal of the product upon request by the TNEMRI or any federal, state or local authority, TN EMRI shall take such action as it deems necessary to recall or withdraw the product from field (Ambulances in the field) and Supplier shall immediately reimburse for the costs and expenses incurred.

**31. Re-Allocation / Cancellation of TENDER:**

In case of failure on the part of the successful vendor to supply, install and commission the GPS within the stipulated date mentioned in the purchase order, TNEMRI at its sole discretion may cancel the purchase order in full, or part, and re-allot the same to next lowest vendor who otherwise fulfills all conditions or may go for retendering as per Tender Act.

**Penalties:**

- a. The penalty for late delivery & installation will be imposed at the rate of 0.5 per cent of the value of contract per week for maximum of 10% after which no delivery will be accepted and the Performance Bank Guarantee will be forfeited.
- b. Late delivery shall mean any day beyond 'firm' delivery date.
- c. Any violation of service support will automatically result in forfeiture of EMD/PBG.

**32. Payment terms:**

- a. 30 days credit from date of submission of monthly invoice against delivery, installation, inspection, commissioning, acceptance
- b. The vendor should submit the bills/invoices and order copy with satisfactory inspection report of the designated Technical Committee as indicated in purchase orders, duly signed and accepted should be submitted at TNEMRI, Chennai in original. Three copies of each document



should be made and one copy handed over to the authority at delivery site.

#### **34. Fraud & Corruption:**

The bidder, suppliers & contractors shall observe the highest standard of ethics during bidding and during performance of the contract. For the purpose of this provision, the following acts shall be considered as corrupt and / or fraudulent practices-

- a) "Corrupt Practices" means offering, giving, receiving, or soliciting directly or indirectly, of anything of value to influence the action of an official in the procurement process or in contract execution.
- b) "Fraudulent Practice" means misrepresentation or omission of facts in order to execution of contract.
- c) "Collusive practice" means a scheme or arrangement between two or more bidder, with or without the knowledge of the purchaser, designed to establish bid prices at artificial, non-competitive level.
- d) "Coercive Practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in a procurement process or in execution of a contract.  
During the process of evaluation of a bid or proposal of an award of a contract, if it is detected that a vendor directly or through agent has engaged in corrupt, fraudulent, collusive or coercive practice in competing for the contract in question, then a) the bid shall be rejected and b) declare the firm ineligible for a specific period or indefinitely to participate in a bidding process.

#### **35. Jurisdiction:**

All disputes arising out of or in connection with this TENDER shall be referred to law courts within jurisdiction of State capital only.



### **36. Ownership of TENDERS:**

All designs, drawings, specification sheets etc submitted shall remain property of TN-EMRI

### **37. Force Majeure:**

The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

- For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- If a Force Majeure situation arises, the Supplier shall promptly notify the Purchaser in writing of such conditions and the cause thereof Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

### **38. Dispute Redressal Committee**

All disputes can be addressed by amicable settlement by committee constituted by SHO, EMRI Green Health Services, TN. / respective departmental ordering authority in Health.

### **39. Power of Cancellation:**

Procurement Committee constituted to evaluate this tender reserves the right to cancel the TENDER notification and reject all the TENDERS in part or full, at any time during the process of receipt, evaluation, and finalization of TENDERS and at any stage of supply of GPS, without assigning any reason what-so-ever.



**40. Indemnity:**

The Supplier shall at all times indemnify the Purchaser against all claims which may be made in respect of the items, for infringement of any right protected by Patent, Registration of design or Trade Mark and shall take all risk of accidents or damage which may occur or failure of the supply from whatever cause arising. The Supplier shall be entirely responsible for the sufficiency of all the means used by them for the fulfillment of the contract

**41. Termination at Purchaser's Discretion:**

TN EMRI may, at any time, terminate the contract for any reason by giving the Supplier notice of termination. Upon receipt of the notice of termination, the Supplier shall either immediately or upon the date specified in the notice of termination, cease all further work except for such as the Purchaser may specify in the notice of termination. In the event of termination of the Contract, the Purchaser shall only pay to the Supplier the Price for the device maintained by the Supplier as of the date of termination.

**42. Governing Law:**

The Contract entered into between the Company and the Supplier shall be governed by and interpreted in accordance with the Laws of India. The place of jurisdiction shall be the place where the Purchaser is located, unless otherwise specified.

**43. Local Conditions:**

It will be imperative on each vendor to fully acquaint himself of all local conditions and factors that would have any effect on performance of the Contract. The purchaser shall not entertain any request for clarifications from the vendor regarding such local conditions nor shall accept any offer conditional to the local factors. No request for any change of price or extension of time schedule of delivery of goods shall be entertained after purchaser accepts the items and services.



**44. Authority for Signing Documents:**

A person signing the TENDER Form or any document, forming part of the contract on behalf of the supplier, shall carry the authorization letter stating his / her authority to sign such documents from the respective organization. Any Agent who is participating on behalf of a manufacturer shall have the valid authorization letter on behalf of the manufacturer to sell the goods in the area where the TENDER is meant for, without which the bid will not be considered as valid.

**45. Responsibility for Performance of Contract:**

The Supplier shall be entirely responsible for the performance of the contract in all respects in accordance with the terms and conditions as specified in the Contract.
